#### **Project Summary (150 words or less):**

The project consists of replacing eight (8) of the existing nine (9) lean burn natural gas engine drivers used in natural gas storage compression service with eight (8) re-manufactured, more efficient and lower emissions rich burn natural gas engines to reduce oxides of nitrogen (NOX), volatile organic compounds (VOC), and particulate matter (PM) emissions. Additionally, the project will include changing the control panel on each unit, fan blades and hubs on the existing fan coolers to more efficient blades and replacing one of the interstage cooler bundles for one with more cooling area.

Task 3: Execution of Contracts and Purchase and Installation of Equipment is currently in progress. Work Orders (WO) are currently being prepared for the installation of the Engines and Interstage Coolers. Request for Quotation (RFQ) are being prepared for the following: 3-Way Catalyst, Control Panels and Engineering Contractor. B. Indicate which Tasks have been completed and any associated accomplishments to date. Describe any challenges encountered during the completion of these Tasks. Discuss actions taken to resolve them.

Task 1:Secure Rights to Location was completed with Enstor's 09/14/2021 submittal of documentation of property rights to project location at 25959 Westheimer Parkway, Katy, Texas 77494.

Task 2: Secure All Necessary Permits to Install and Operate Project were completed by 11/15/2021. Enstor Katy provided evidence of sufficient insurance coverage for this project on 09/14/2021. Enstor Katy received the necessary permits to install and operate eight replacement natural gas engines for the purposes of decreasing NOx, VOC and PM emissions on 11/15/2021.

Task 3: Execution of Contracts and Purchase and Installation of Equipment. Request for Quotations were issued for the following: Natural Gas Rich Burn Engines, interstage coolers, new fans, shim packs, equipment transportation, engine installation and cooler installation. Bids were evaluated and a vendor (Enerflex Energy Systems) was selected to supply the equipment, materials and construction services. Four (04) Purchase Orders (PO) were issued for the following: Engines Equipment, Engine Supplies & Materials, Interstage Cooler Equipment, and Interstage Cooler Materials & Supplies, respectively. Terms and conditions for the installation component of the work were agreed to and a Master Service Agreement (MSA) was signed between Enstor and the selected vendor (Enerflex Energy Systems).


